

## MINUTES

### BANGOR SCHOOL COMMITTEE ORGANIZATIONAL MEETING 11:00 a.m., Monday, November 14, 2011

School Committee Members present: Chairman Phyllis Guerette, Vice Chairman Christine Szal, Warren Caruso, Kate Dickerson, Nichi Farnham, and Jay Ye. Committee Member Beth Grant was unable to attend.

The Bangor School Committee Organizational Meeting was called to order by Superintendent Webb at 11:01 a.m. and the Pledge of Allegiance followed.

- A. Patti Dubois, City Clerk, swore in newly elected School Committee Members Warren Caruso, Phyllis Guerette, and Christine Szal.
- B. 1. Committee Member Christine Szal nominated Phyllis Guerette to be Chair of the Bangor School Committee. Committee Member Nichi Farnham nominated Kate Dickerson to be Chair of the Bangor School Committee.

Members of the Committee spoke to the strengths of the two nominated individuals.

VOTE: Caruso, Guerette, Szal, and Ye voted in favor to elect Phyllis Guerette as Chair of the Bangor School Committee.

2. Committee Member Christine Szal nominated Warren Caruso to be the Vice Chair of the Bangor School Committee. Committee Member Kate Dickerson nominated Nichi Farnham to be Vice Chair of the Bangor School Committee.

Members of the Committee spoke to the strengths of the two nominated individuals.

5. Superintendent Webb recommended appointment of Dr. Kristen Martin as School Physician.


VOTED 6-0 to approve the appointment as presented.
